## ENROLLMENT/FINANCIAL CONTRACT

Please read and initial each item and sign the appropriate space on the back.

- \_\_\_ 1. Trinity Christian School agrees to assist parents in their God-given responsibility of educating their children in the nurture and admonition of the Lord.
- \_\_\_ 2. This enrollment contract is subject to the general statements, policies, rules, regulations, conditions, traditions, and financial terms, as indicated in the Trinity Christian School Handbook, the 2010 – 2011 Tuition and Fee Schedule and the yearly calendar – ALL are acknowledged to be incorporated into this enrollment contract, and with which I/we have taken the opportunity to read and become familiar with. I/We agree to support and encourage school functions and to attend and support Trinity Christian School whenever possible.
- \_\_\_ 3. I/We have read the Statement of Faith and agree that my/our child may be taught according to the doctrinal basis contained therein understanding that the teaching at Trinity Christian School will be consistent with the system of Biblical beliefs contained in the Westminster Confession of Faith.
- \_\_\_ 4. I/We agree to follow the Matthew 18 principles for resolving all grievances and complaints with the school and its staff and to strictly adhere to the complaints policy as set forth in the Trinity Christian School Handbook.
- \_\_\_ 5. I/We understand that enrollment and re-enrollment at Trinity Christian School is by invitation only. Strict adherence to the Trinity Christian School Handbook is required for continued enrollment. Current enrollment and attendance at Trinity Christian School does not guarantee or create a right of re-enrollment for subsequent school years.
- \_\_\_ 6. I/We understand that a non-refundable registration/curriculum fee, as stated in the Tuition and Fee Schedule, is required and must be submitted with the application for enrollment.
- \_\_\_ 7. I/We agree to the financial policy stated in the 2010 – 2011 Tuition and Fee Schedule and the current Trinity Christian School Handbook. I/We agree to pay all amounts due on a timely basis and keep our child's account current.
- \_\_\_ 8. I/We agree to pay a fee of \$1000 per child should I withdraw my children from the school from June through November or \$750 if I withdraw them from December through May for any reason. In addition, I will pay all tuition due through the month of withdrawal and all book and supply fees for the year. These fees are payable immediately upon withdrawal.
- \_\_\_ 9. I/We agree to pay any and all costs and expenses incurred by Trinity Christian School on account of my failure to adhere to the terms of the current Trinity Christian School Handbook, including, and without limitation, court costs, reasonable attorney's fees and disbursements.
- \_\_\_ 10. I/We agree that the Trinity Christian School Principals and/or School Board reserve the right to dismiss any student, require a mandatory leave of absence of any student, and/or rescind the admissions invitation or enrollment contract of any student, at any time, for any reason, they deem necessary.
- \_\_\_ 11. I/We agree with the standards of conduct and discipline set forth in the Trinity Christian School Handbook and grant authority to the teacher and Trinity Christian School administration to discipline my/our children whenever and however they deem necessary. I/We understand that this may include corporal punishment.
- \_\_\_ 12. I/We agree to participate in weekly worship as a family at a local church.

- \_\_\_ 13. I/We do hereby grant a perpetual license to Trinity Christian School to photograph or video my/our child and to use my/our child's name, grade and activity description for school publicity, press releases and school publications (electronic or otherwise).
- \_\_\_ 14. I/We do hereby agree to adhere to the Medical/Sickness policy set forth in the Trinity Christian School Handbook. I/We authorize Trinity Christian School to obtain immediate medical care if a medical emergency should occur and the parents cannot be found immediately. Such authorization may be given to a physician or hospital other than the family's physician, if in the school's or its employee's judgment, there is insufficient time to first contact the family's physician. I/We release Trinity Christian School from any liability which might arise from the giving of such authorization; It being my/our desire that my/our child be furnished with such medical services as soon as reasonably possible after the need arises.
- \_\_\_ 15. I/We authorize my/our children to participate in all school related field trips. I/We agree to: 1) accept general liability for the participation of my/our child during these activities, and 2) hold harmless Trinity Christian School, their officers, employees, directors, and volunteers from claims, liability or suits arising from my/our child's misbehavior or disregard of regulations while participating in any field trip. If transportation is provided in a privately owned vehicle, the driver is responsible for his/her passengers' well being. I/We agree to carry and supply proof of auto liability insurance prior to transporting any student on behalf of Trinity Christian School.
- \_\_\_ 16. I/We agree that except as expressly exempted from these provisions, any and all claims or disputes which would otherwise be the basis for legal or court action, which arise from or are related to the school and its operation, including all aspects of the student's relationship with the school, its administrators, faculty, and staff shall be settled by mediation and, if necessary, legally binding arbitration. The mediation shall take place in Opelika, Lee County, Alabama. Exempted from the provisions of these mediation and arbitration provisions is the collection of monies due to Trinity Christian School for tuition or other charges. Such collections may be enforced directly by legal action. The mediation and arbitration provisions created herein are not intended and do not give parents, guardians, or other legal representatives standing to arbitrate matters arising from the administration and implementation of the school's educational function.
